FREQUENTLY ASKED QUESTION / TERMS AND CONDITIONS OF PURCHASE

Q1. WHERE IS REGENT PARK LOCATED?

REGENT PARK is located at Akodo close to Eleko junction.

Q2. WHO ARE THE OWNERS/DEVELOPERS OF REGENT PARK LAGOS

PWAN ADVANTAGE RESOURCES LTD, a leading Real Estate Company with OFFICES IN LAGOS, Uyo, Akwa-Ibom State, Portharcourt, Rivers State, Asaba, Delta

Q3. WHAT TYPE OF TITLE DOES REGENT PARK HAVE?

Gazzete.

Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?

The land is free from any known Government acquisition or interest or adverse claims.

WHAT IS THE PAYMENT STRUCTURE?

Outright Payment of 5,800,000 per 600sqms & 2,900,000 per 300sqms Installmental Payment (6 months): 6,200,000 per 600sqms and 3,100,000 per 300sqms Installmental Payment (12 months): 6,600,000 per 600sqms and 3,300,000 per 300sqms

CAN I RE-SELL MY PLOT/ PROPERTY? 015.
